#### I. Call to Order and Introductions

Meeting was called to order at 5:17 pm by John Wolcott, Chair.

#### II. Approval of November 2015 Minutes

The November 2015 minutes were not presented for approval.

### III. Community Feedback and Announcements

Wolcott -

- Benton County Jail levy did not pass
- Housing First and the organization that sponsored the women's shelter during the winter have joined forces into one organization. A committee has been formed to keep the homeless folks out of downtown Corvallis

#### IV. Old Business

Substance Abuse Issues

Will Bauscher, Division Chief of the Corvallis Fire Department Emergency Management Services and Greg Riddler, Undersheriff of Benton County, currently acting Sheriff are present today to provide an overview of their programs and answers questions regarding substance abuse in Benton County.

Bauscher provided a handout that contained general overview, staffing, importance to community, and challenges. In addition, he shared the following information:

 Provides ambulance transportation services for majority of Benton County, portion of Linn and Polk Counties and small portion of Lane County totally 73 square miles of ambulance calls. There are a total of 3 ambulances staffed 24/7.

- Typical type of calls being responded to are general medical or crisis calls that deal with developmental disabilities, chronic ailments, alcoholism, homelessness, etc.
- In 2014 the organization saw 4,804 patients who all had medical assessments.
   391 had some sort of drug or alcohol factor associated with their assessment.
   Of those 254 had provider impression where there is some sort of behavior or psychiatric issue; about 5% of the calls. To qualify the 2014 data, prior to July 1 2014, did not specifically track alcohol or drug indicators.
- In 2015 to date the organization saw 4,516 patients with 605 of those having alcohol and other drug indicators, 230 presented with behavioral or psychiatric issues. Approximately 13% of the calls they go out on have some sort of drug or alcohol issues associated with their complaint with 5% having behavioral issues. The biggest challenge they have is what to do with these folks.
- The department ensures that individuals have a choice and honor those in keeping with their rights and civil liberties. If they have capacity to refuse care then required to honor that decision. This is about 25% - 30% which involves non transport
- When dealing with questionable capacity it can be difficult to figure out where to take the patient. Getting the patient to the right place, in the right way, in the right time frame, and right mode of transportation to meet their needs. The dilemma is that there is not a lot of choices which means the emergency room at Good Samaritan is the fall back.
- Reimbursement issues have been a challenge. In our community ambulances are fee for services and typically not tax based. There are very few exceptions to this. There is a fee charged for all transports, currently that fee is \$1200 plus \$18 per mile. Typically this can be covered by insurance but can affect those with high deductible plans. If a patient declines transport, and there is no advance life support or invasive procedures done, they will not be charged. Options are available for payment such as make payments with no interest or charitable write off process for low income.
- Approximately 45% of the response calls to Oregon State University is related to alcohol.
- Halloween night responded to 29 patients with confirmed alcohol indicators identified, 20 of those required transport.
- Anecdotally seeing increase in opioid utilization, chronic use methadone in treatment and associated with abuse. More concern is the alcohol use which is typical for the demographics.
- Concerned regarding mental and behavioral health issues in the area right now.
   Seeing a fairly frequent increase in individuals that are "frequent users". There was an individual that was transported 11 times last month.

• Just because individuals are taken to the hospital ER does not necessarily mean they will be admitted.

Greg Riddler of Benton County Sheriff's Office stated his background is in law enforcement. He has been a police office for 32 years, with the last 10 years here in Benton County. Currently he is transitioning into more of the Corrections and Parole and Probation side of things. The following information was noted:

- Jurisdiction is mostly outside City of Corvallis
- Biggest impact is the influx of what to do with people in regards to the jail.
- Similar to City of Corvallis EMS, law enforcement also has some frequent users.
   Short term solutions are only addressed for these types of callers instead of the ideal long term solutions.
- Law enforcement also may take individuals to the hospital for evaluation if they refuse transport from EMS.
- Drug Court can be successful for the individual who has the right attitude for the drug program and wants to succeed. If an individual breaks drug court protocol and is sanctioned to jail then this usually kicks another person out of jail due to lack of room. The drug court individual knows that they will only be put in jail for up to a few days since there isn't enough room in the jail. If the jail is "closed" then all that law enforcement can do is give a ticket and have them appear in drug court again. There is no incentive for them to have good behavior. The current jail is not effective.
- The new jail would have provided those who were arrested and in need of mental health services to obtain services while incarcerated.
- DUII first offenders are offered a diversion program. The majorities of first offense individuals are aware of this program and immediately ask for it. Taking away DUII offender's license has not seemed as sufficient penalty, as there are many in the community with 2-3 DUII offenses and still driving while suspended. Law enforcement deals with this on a daily basis of people driving while suspended and having no insurance. Giving them a ticket does not seem to influence them. It's about a 50% chance that when accidents happen that a driver has been suspended license and no insurance.
- Oregon does not allow DUII check points.
- Problem they deal with on a daily basis is those individuals say you can't do anything to me.
- For the most part, people have the right to do what they want in the privacy of their own home as long as it is not impacting society.

#### Stepping Up Initiative Follow-Up

This is a National Association of Counties Initiative to help provide technical assistance to build services and supports to divert individuals from jail, especially those dealing with mental health issues. Benton County will be applying to the application process put out by SAMHSA's GAINS Center. The planning process would happen in late spring. The state has also asked the GAINS Center to come out and provide a train the trainer session. There is also a national conference being planned for April and looking at sending folks to this conference.

#### V. New Chair and Vice Chair Positions

In January of each year MHADDAC members nominate and elect the Chair and Vice Chair positions. Wolcott asked members if they are interested in either position to contact Tammy. Election will happen at the January meeting.
