BILLS OF INTEREST

- SB 1564 Optional Model Housing Ordinances

- SB 1529– Emergency Weather Resources Update





SB 1537

- Housing Accountability and Production Office (HAPO)
- \$3 million for access to infrastructure programs
- Moderate-income housing revolving loan fund
- One-time UGB expansion
- Requires acceptance of up to 10 adjustments to siting and design standards

SB 1530

- ~\$280 million allocation to support SB 1537
 - \$65 million for existing shelters
 - \$95 million directly to cities
 - \$36 million to OHA
 - \$30 million to DAS
 - Financial allocations scaled down from original proposal, but still a massive allocation for a short session

- \$5 million for relocation of Children and Family Services Center
- \$2.5 million to add 11 units to the County Flexible Housing Subsidy Pool
 - Pared down from original ask of \$4.9 million

Benton/Corvallis Situation Table

Six month update

What is the Situation Table?

- Structured program
- Collaboration across multiple service sectors
- Addresses individuals or families at Acutely Elevated Risk
- Mobilizes resources tailored to their situation
- Rapid response 24 to 48 hours

Where did the Situation Table come from?

- Originated in Prince Albert, Saskatchewan in 2011
 - Adapted from a Scottish program
- Has become widespread in Canda
 - 14 Tables in Saskatchewan
 - 70 Tables in Ontario
- Started in Chelsea Massachusetts in 2015 ("Hub Model")
 - Most dangerous city in Massachusetts in 2014, #11 in US
 - Off the "Most Dangerous Cities" list by 2019

How did it end up here?


- HOPE Advisory Board (Home, Opportunity, Planning and Equity) formed in fall of 2019
- Twelve recommendations in spring of 2021, including a coordinated response
 - Three major milestones:
 - Building support among service providers
 - Identifying a hosting agency (CORE Team)
 - Securing funding for training (IHN-CCO)
- Training held October 19 & 20, 2023
- First Situation Table October 29, 2023


How does it work?


- Four filter process:
 - Filter 1: Originating agency screening (frontline staff)
 - Filter 2: De-identified discussion at Situation Table
 - Gender, age range, risk factors, synopsis
 - Group consensus of AER must be achieved to move to Filter 3
 - Filter 3: Identifiable discussion for agency recognition/filter 4 identification at Situation Table
 - Filter 4: Response planning at Situation Table, with intervention within 24-48 hours in the field




How have the first six months gone?










Reason for Closure	Count
Rejected - Originator has not exhausted all options to address the issue	1
Rejected - Situation not deemed to be one of acutely-elevated risk	1
Overall risk lowered - connected to services	20
Overall risk lowered - connected to personal supports	1
Still AER - Informed about services; not yet connected	3
Still AER -Refused services/uncooperative	2
Still AER - Systemic issue	4
Other - Unable to locate	1



Coordinated Homeless Response System: The HOPE Advisory Board's Role



Forum for community and stakeholder engagement, consisting of a wide array of community expertise and representation of groups working on homelessness, housing, and social determinants of health.



Liaison between the community and the member governments in collaboration with the Coordinated Office for communications, community engagement, and informed decisionmaking for elected officials.



Input to support the development of programs and ongoing updates of the 5-year Strategic Plan.



HOPE 2024 Work Plan

<u>May:</u> Flexible Housing Subsidy Pool (FHSP) progress on program implementation – another opportunity for community partner engagement as we move forward with implementation.

<u>August:</u> Final community engagement session on the FHSP.

October: Severe weather emergency response plan.

*We will be seeking HOPE members to volunteer on smaller work groups for specific projects. Example: FHSP and a Notice of Funding Opportunity (NOFO) Review Committee with participation from people with lived experience with homelessness.

- Housing Navigator for direct client support with housing navigation, care coordination, referrals and housing placement.


Community Capacity (NOFO)

- Street Outreach to connect people experiencing homelessness with the system of care and referrals to the FHSP.
- Case Management to support people on their housing journey and make connections to FHSP resources.


