 - i. CHRO updated the whole document to include outline format (I.A.1.a.)

 - iii. CHRO added language about work groups flexibility in the leadership, facilitation, or format of work groups based on the topic and relevant funding streams associated with the topic.
 - b. CHRO staff has also removed "CSC" and "Cities" from I.A.1. so we do not need to amend Bylaws with every new member (LBHA, IHN, etc.)

 - d. Question from CHRO staff about last value listed: equity. Amending "equity" to

"engagement" for purposes of federal requirements. Amending equity value section accordingly.

- V. Coordinated Homeless Response Round Table Updates
 - a. CHRO staff updates?
 - i. City issued a building permit for Unity Shelter for mens shelter improvements. Site approval for s. town of affordable housing development. Progress continues for affordable housing near Wal-Mart in Corvallis.
 - ii. Philomath city council approved exclusivity permit (valid for 18 months) for 33 affordable housing units with Commonwealth applying for funding through the state. Philomath is looking at providing a substantial discount to the purchase of property.
